

HON FLOCK MINI® Sweepstakes **Official Rules**

NO PURCHASE NECESSARY

1. Sweepstakes Eligibility: HON FLOCK MINI Sweepstakes (“Sweepstakes”) is sponsored by The HON Company LLC (“HON”). The Sweepstakes is open to residents of the continental United States who are at least eighteen (18) years old at the time of entry. To be eligible to participate (“Eligible Participant”), an entrant must have received an email or direct mail piece from HON inviting them to participate in the Sweepstakes, or be an employee of the business which received the email/direct mail. Employees of HON, HON’s dealers, and their respective affiliate companies and immediate family members are not Eligible Participants. The Sweepstakes is void where prohibited by law.

2. Sweepstakes Administrator: The Sweepstakes administrator is MarketNet Solutions, Inc. (“Administrator”) 14998 Cleveland St., Spring Lake, MI 49456.

3. Sweepstakes Period: Eligible Participants can enter the Sweepstakes from February 1, 2017 at 8:00 a.m. Eastern Time to April 30, 2017 at 8:00 p.m., Eastern Time (“Registration Period”). The Administrator’s computer is the official time keeper for the Sweepstakes.

4. How to Enter: During the Registration Period, visit our website at bit.ly/Flock2017 and follow the instructions. Entries submitted by sweepstakes aggregators or similar method are not valid or an Eligible Participant. One (1) entry per person.

5. Selection of Sweepstakes Winners: By May 5, 2017 the Administrator will randomly draw the Sweepstakes winners from entries of Eligible Participants received during the Registration Period. Winners will be notified by email or phone on or before May 26, 2017. Each winner will be sent an Affidavit of Eligibility, Liability & Publicity Release (“Release”) and a W-9 form to pay taxes (if prize fair market value exceeds \$600) on the prize and will need to sign and return both to the Administrator within five (5) days of the date sent. If a winner doesn’t sign and return the Release and W-9 within this time period, the winner forfeits its prize. If a prize is forfeited, the Administrator will draw a winner from the remaining entries of Eligible Participants. After 2 forfeitures per prize, a prize will not be awarded.

Sweepstakes prizes will be provided and shipped directly to an authorized HON dealer prior to winners being selected and verified. Product is pre-ordered before the sweepstakes campaign launch and delivered to dealerships; there are no substitutions or customizations to fabrics/finishes. Each participating HON Connect dealership will have two (2) Flock Minis to award. The first person to respond with completed affidavits and release forms for each dealership will have their choice of the two minis. The next person who responds will get the one not chosen. Winners will be contacted by the sweepstakes administrator to confirm winning and collect forms. Once forms are completed, the winner’s name and information will be passed to the dealer to arrange for fulfillment of the prize.

6. Prizes and Odds of Winning: Two (2) Flock Minis will be awarded per participating HON Connect dealership location. Product is pre-ordered before the sweepstakes campaign launch and delivered to dealerships; there are no substitutions or customizations to fabrics/finishes.

Approximate Retail Value of each Flock Mini is (“ARV”): US\$812 List price, which is Fair Market Value of \$406. Total ARV of all prizes: US\$198,128. Limit: One (1) Flock Mini per winner. A prize is not transferable or redeemable for cash. HON reserves the right to substitute a prize, finish or other option for one of equal or greater value. Each winner is responsible for the taxes associated with winning a prize. Odds of winning a prize depend on the number of entries received from Eligible Participants during the Registration Period.
